RELEASE OF INFORMATION FOR SUPERVISION PURPOSES

Schawn Austin, LPC-Intern is currently providing therapeutic services under the supervision of **Patty Evers, LPC-S**. While a LPC-Intern, Schawn Austin must participate in weekly supervision with her supervisor, Patty Evers, LPC-S. The purpose of supervision is to help Schawn Austin, LPC-Intern become better skilled as a therapist. To this end, the content of counseling sessions with Schawn Austin, LPC-Intern will be discussed with Patty Evers, LPC-S. Patty Evers, LPC-S is under the same ethical and legal regulations as all LPC's in the state of Texas.

In Texas, the Licensed Professional Counseling - Intern (LPC-Intern) license is given to an individual who has completed all the educational requirements, passed the licensing exam and the jurisprudence test just as a fully Licensed Professional Counselor (LPC) has. A LPC-Intern must work their first 3000 hours under the supervision of a Professional Licensed Counselor, who has at least 5 years' experience and has completed the state mandated supervision training in order to become a LPC-S.

Schawn Austin, LPC-Intern sees clients at Her supervisor's offices, Hill Country Parenting. The client file are the property of Patty Evers and Hill Country Parenting and will remain at Hill Country Parenting in accordance with all applicable laws even after Schawn Austin, LPC-Intern no longer works at Hill Country Parenting. Requests for copies of client files or documents should be directed to Patty Evers LPC-S at Hill Country Parenting. That request can be processed through Schawn Austin, LPC-Intern if she is still working at Hill Country Parenting.

All payments for services provided by Schawn Austin, LPC-Intern are made to Hill Country Parenting and Patty Evers, LPC-S. Checks should be written to Hill Country Parenting (or HCP). Credit Card Charges will be processed through Hill Country Parenting. Schawn Austin, LPC-Intern is authorized to accept cash payments for Hill Country Parenting. Schawn Austin, LPC-Intern is authorized to set and adjust the fee charged for the services she provides at Hill Country Parenting.

If you are uncomfortable having Schawn Austin, LPC-Intern discuss the specifics of your or your minor child's counseling sessions with her supervisor you have the right to decide to seek services with a fully licensed counselor. If this is your decision, Schawn will provide referrals to fully licensed counselors.
