RELEASE OF INFORMATION FOR SUPERVISION PURPOSES

Schawn Austin, LPC-Intern is currently providing therapeutic services under the supervision of **Joe Dias, LPC-S**. While a LPC-Intern, Schawn Austin must participate in weekly supervision with her supervisor, Joe Dias, LPC-S. The purpose of supervision is to help Schawn Austin, LPC-Intern become better skilled as a therapist. To this end, the content of counseling sessions with Schawn Austin, LPC-Intern will be discussed with Joe Dias, LPC-S. Joe Dias, LPC-S is under the same ethical and legal regulations as all LPC's in the state of Texas.

In Texas, the Licensed Professional Counseling - Intern (LPC-Intern) license is given to an individual who has completed all the educational requirements, passed the licensing exam and the jurisprudence test just as a fully Licensed Professional Counselor (LPC) has. A LPC-Intern must work their first 3000 hours under the supervision of a Professional Licensed Counselor, who has at least 5 years experience and has completed the state mandated supervision training in order to become a LPC-S.

Schawn Austin, LPC-Intern sees clients at Her supervisor's offices, Mr D Counseling. The client files are the property of Joe Dias, LPC-S and Mr D Counseling and will remain at Mr D Counseling in accordance with all applicable laws even after Schawn Austin, LPC-Intern no longer works at Mr D Counseling. Requests for copies of client files or documents should be directed to Joe Dias LPC-S at Mr D Counseling. That request can be processed through Schawn Austin, LPC-Intern if she is still working at Mr D Counseling.

All payments for services provided by Schawn Austin, LPC-Intern are made to Mr D Counseling and Joe Dias, LPC-S. Checks should be written to Mr. D Counseling. Credit Card Charges will be processed through Mr D Counseling. Schawn Austin, LPC-Intern is authorized to accept cash payments for Mr D Counseling. Schawn Austin, LPC-Intern is authorized to set and adjust the fee charged for the services she provides at Mr D Counseling.

If you are uncomfortable having Schawn Austin, LPC-Intern discuss the specifics of your or your minor child's counseling sessions with her supervisor you have the right to decide to seek services with a fully licensed counselor. If this is your decision, Schawn will provide referrals to fully licensed counselors.
